





- 1. The Department of Education (DepEd), through the Office of Secretary (OSEC), has officially launched the *Professional Development Program on Assessment and Emerging Literacies with Focus on PISA (Assessment PD)* last October 23, 2021. This program, which will run until April 2022, aims to improve teachers' assessment strategies, methods, and practices to help them align their classroom instruction and assessment with the emerging standards measured by International Large-Scale Assessments (ILSAs).
- 2. A total of **20,521 teachers** registered to participate in the Assessment PD when the registration officially ended last October 25, 2021. Out of this number, around **4,818 teacher participants** were found to have erroneous registration details due mainly to typographical errors committed in accomplishing the registration form. As a result, these teacher participants could not access the "Assessment and Emerging Literacies" course category on the learning management system (training.deped.gov.ph) and are unable to receive official program communication via email.
- 3. In this light, the Assessment PD Secretariat has released an official **Data Correction form** that teacher participants with erroneous registration details must fill out to correct their registration information. The Data Correction form can be accessed at https://tinyurl.com/APDCorrections. Specifically, only those teacher participants who are currently not receiving emails from the Assessment PD Secretariat (assessmentpd.secretariat@deped.gov.ph) and who cannot access the "Assessment and Emerging Literacies" course on PD LMS must participate in the Data Correction process.

- 4. The list of teacher participants who must accomplish the Data Correction form can be viewed at https://tinyurl.com/APDSegment4. We would like to thank you and your staff in advance for your kind assistance in reminding the listed teacher participants under your jurisdiction to always double-check their registration details and to fill out the Data Correction form as soon as possible using their respective **DepEd email addresses**.
- 5. We would also want to clarify that due to the volume of the registered teacher participants and the limitations of our resource persons and partner Learning Service Providers (LSPs), we can no longer accommodate requests for inclusion of additional participants for this cycle of the Assessment PD. Although the time allotted for the registration was limited, our office has reopened the registration process at least twice before finalizing the list of participants. Thus, junior high schools that were unable to send representatives to this cycle of the program may do so in the following cycles instead.
- 6. The deadline to fill out the Data Correction form is on **Monday, December 6**, **2021**, at **11:59 PM**. Those who will accomplish the data correction form may expect feedback from the Assessment PD Secretariat within a week after the deadline.
