

SEARCH FOR THE BEST INTEGRATION OF FINANCIAL LITERACY KEY CONCEPTS IN SCIENCE AND MATHEMATICS THROUGH SELF-LEARNING MODULES

To: OIC-Assistant Regional Director

- 1. The Department of Education (DepEd), through the Bureau of Curriculum and Development (BCD), in partnership with BDO Foundation Inc. and Huawei Technologies Phils. Inc., will conduct the Search for the Best Integration of Financial Literacy Key Concepts in Science and Mathematics (FLICSM) through Self-Learning Modules (SLMs).
- 2. The search is an SLM-writing competition for teachers on developing creative and innovative SLMs that best integrate financial literacy concepts in Science and Mathematics. It aims to promote understanding of learners on financial literacy concepts using the SLMs developed by teacher-writers. The integration of financial literacy will enable learners to better understand the importance of life skills such as budgeting, saving, investing, among others, through the connection of learning content and its real-life applications established in the lessons.

Additional Guidelines in Conducting the Search at the Regional and Division Offices

In addition to the guidelines of the competition as stipulated in **DepEd Memorandum No. 83, s. 2021**, the following guidelines shall be adopted to facilitate the submission of entries from the division to the regional level.

- 1. Each division office shall conduct its own search and endorse, at most, one (1) official entry for each category.
 - a. SLM in Mathematics for Elementary (Grades 4 to 6)
 - b. SLM in Mathematics for Junior High School (Grades 7 to 10)
 - c. SLM in Science for Elementary (Grades 4 to 6)
 - d. SLM in Science for Junior High School (Grades 7 to 10)

2. The dates for the various activities for the competition are as follows.

- 3. Submission of entries to the regional level is done online. The writer is requested to fill-out the submission form and upload his/her entry and other requirement through this link: https://tinyurl.com/FLICSM-SF. Among the documentary requirements to be submitted online are as follows:
 - a. Scanned endorsement from division office (PDF format)
 - b. Notarized Certification (PDF format) See Enclosure No. 2 to DM 83, s. 2021
 - c. Writer's Declaration of Warranties Form with Declaration (PDF format) See Enclosure No. 3 to DM 83, s. 2021
 - d. Bionote of writer (PDF format)
 - e. Checklist of the submitted requirements signed by the learning resource evaluator of the division (PDF format) See Enclosure No. 4 to DM 83, s. 2021
- 4. At the regional and division levels, winners for each category will receive certificates of recognition and cash prizes depending on the availability of fund and subject to the usual budgeting, procurement, accounting and auditing rules and regulations.
- 5. The top 2 winners from each category at the regional level shall be endorsed as official entries to the National Level.

6. To facilitate the judging of entries, the regional and division offices shall form a set of evaluators/judges. The SLMs shall be evaluated in terms of **content**, **extent of integration**, **language**, and **layout and design**. The region and division offices shall develop their own scoring rubric to evaluate the entries.

- The disruption brought about by the COVID-19 pandemic is heavily felt not just in navigating education practices and learning delivery, but more so with the financial capabilities of families as economic instability is taking a toll in most countries. It is imperative that students as well as parents, teachers and administrators, are equipped with knowledge and skills towards financial literacy. The government strongly supports the promotion of financial literacy through the enactment of Republic Act No. 10679 known as the Youth Entrepreneurship Act. Furthermore, DepEd Order No. 022, s. 2021 titled Financial Education Policy emphasized that financial education is vital in developing financially literate citizenry, in empowering them to make wise financial decisions, in taking advantage of economic opportunities, and in achieving financial health.
- The Department of Education (DepEd), through the Bureau of Curriculum Development (BCD), in partnership with BDO Foundation Inc. and Huawei Technologies Phils. Inc., announces the conduct of the Search for the Best Integration of Financial Literacy Key Concepts in Science and Mathematics (FLICSM) Through Self-Learning Modules.
- The Search for the Best Integration of Financial Literacy Key Concepts in Science and Mathematics through Self-Learning Modules (FLICSM) is an SLMwriting competition for teachers on developing creative and innovative self-learning modules (SLMs) that best integrate financial literacy concepts in Science and Mathematics.
- This aims to promote understanding of learners on financial literacy concepts using the SLMs developed by teacher-writers. The integration of financial literacy will enable learners to better understand the importance of life skills such as budgeting, saving, investing, among others, through the connections of learning content and its real-life applications established in the lessons. In addition, the competition intends to foster competence, creativity, collaboration, and flexibility among teachers in developing lessons in Science and Mathematics. Winning entries will also add to the quality assured learning materials of the Department that teachers may use in the future.

- 5. The competition is open to all public and private elementary and junior high school (JHS) Science and Math teachers and will consist of four categories: SLMs in Mathematics for Elementary, SLMs in Mathematics for JHSs, SLMs for Science in Elementary, and SLMs for Science in JHS.
- 6. The SLMs must be aligned with the most essential learning competencies (MELCs) in Science or Mathematics of the K to 12 Curriculum. The coverage of the lessons will be anywhere from first to fourth quarter of Grade 4 to Grade 6 for elementary and Grade 7 to Grade 10 for JHS.
- Each region shall endorse, at most, two official entries for each category. Entries for the elementary level may come from any of the grade levels from Grades 4 to 6, while entries for the JHS may be from any of the levels from Grade 7 to 10.
- 8. Winners for each category will receive certificates of recognition and cash prizes as indicated below. Non-winning entries shall receive a consolation prize. All participants will receive a Certificate of Participation.

Competition Mechanics

- 1. The competition is open to all public and private elementary and junior high school Science and Math teachers. There shall be four (4) categories:
 - a. SLMs in Mathematics for Elementary
 - b. SLMs in Mathematics for Junior High School
 - c. SLMs in Science for Elementary
 - d. SLMs in Science for Junior High School
- 2. The SLMs must be aligned with the most essential learning competencies (MELCs) in Science or Mathematics of the K to 12 Curriculum. The coverage of the lessons will be anywhere from first to fourth quarter of Grade 4 to Grade 6 for elementary and Grade 7 to Grade 10 for the junior high school.
- 3. The SLMs may also include the financial literacy training videos by BDO Foundation, Inc, which is made available through the DepEd Portal.
- 4. Entries should be written in English being the medium of instruction of the learning area.
- 5. Each region shall endorse at most two official entries for each category. Entries for the elementary level may come from any of the levels from Grades 4 to 6, while entries for the junior high school may be from any of the grade levels from Grade 7 to 10.
- 6. The Regional Office, through the Curriculum and Learning Management Division (CLMD), must ensure that the entries are compliant with the requirement as identified in the checklist in Enclosure 4.
- 7. Maximum of two teachers may collaborate on the SLM. Teacher-participants must be teaching Math or Science for at least three (3) years. In addition, teacher-writers for the junior high school level should have a specialization in Science or Math or is a graduate of Math/Science-related courses.
- 8. The writer/s are required to fill out the submission form and upload their entries and other requirement online through this link: https://bit.ly/FLICSM. Among the documentary requirements to be submitted online are as follows:
 - a. Scanned endorsement from the Regional Office
 - b. Notarized Certification (Enclosure 2)
 - c. Writer's Declaration of Warranties Form with Declaration (Enclosure 3)
 - d. Bionote of the teacher-writer/s
 - e. Checklist of the submitted requirements signed by the learning resource evaluator (LRE) of the region (Enclosure 4)
- 9. All entries must be received not later than January 31, 2022 at the National Level. Entries received after the deadline will no longer be evaluated. Files must

be saved in PDF version following this filename format: SLM_Level_Learning Area_Region_LASTNAME, e.g. SLM_Elementary_Math_NCR_MARTINEZ

- 10. An entry found to be copied or imitated will mean disqualification from the competition. Intellectual property of the submitted SLMs shall be owned by the proponent/s. Permission will be given to DepEd to allow reproduction of the SLMs, at no cost to DepEd and regardless of the number of copies perpetually, for future use by other teachers.
- 11. There will be a separate set of evaluators/judges for each category. A separate guideline on the process of evaluating/judging the entries shall be issued for the judges. The SLMs will be evaluated based on the agreed set of criteria.

The use of original contents in SLMs submitted by the private and public entities is highly encouraged. The inclusion of any third party content in SLMs must be in accordance with applicable laws and rules, including Republic Act (RA) No. 8293, as amended by RA 10372, or the Intellectual Property Code of the Philippines, which contains provisions on, among others, licensing and assignment of intellectual property as well as limitations and exceptions to copyright. Should permission for use of third party content be necessary, the party submitting the SLM shall secure such permission in writing. In all cases, any and all consequences of the use of any third party content, including any criminal, civil or administrative liability that may result from unauthorized or unlawful use thereof, shall be the sole responsibility of the party submitting the SLMs which contain such third party content.

2. Documentary Requirements

Together with the submission of the digital copies of the SLMs, the following shall also be submitted in digital copies as necessary documentary requirements:

- 2.1 Duly accomplished Submission Form in digital format (Word File) for each set (per grade level, learning area, and quarter) of SLMs. Please see Annex 1 for the template of the Submission Form.
- 2.2 A certified true copy of NBDB Registration or Business Registration/Permit from the local government unit must be submitted by private entities.

C. Technical Requirements of the SLMs

The following are the technical requirements for the submission of SLMs:

1. Instructional Design




Figure 2. Instructional Design (Source: BLD, Oct.11, 2020)

The Instructional Design (ID) is the systematic framework used in designing printed learning resources. It translates the principles of teaching and learning into place for teaching-learning strategies, developmental activities, and evaluative measures that complement the contents. Figure 2 describes the Instructional Design for Q3 and Q4 SLMs which follows the Input-Output-Process.





Self-learning Modules Instructional Design

Curriculum

The Quarters 3 and 4 SLMs to be submitted shall be anchored on the MELCs which can be accessed and downloaded by interested parties from http://lrmds.deped.gov.ph/detail/18275 and https://commons.deped.gov.ph/MELCS-Gudelines.pdf.

Elements per Lesson

This section deals with the elements culled from the ID and describes the guidelines for development of SLMs. However, private and public entities may consider other terms provided that these are synonymous, essential, and consistent in the achievement of learning objectives and presentation in the inside pages.

a. Overview

• contains an *Introduction* that discusses the topic/content of the module and the learning objective/s

Objectives

- · anchored on MELCs
- · inform the learners of the expected outcomes

Pre-assessment

check the learner's knowledge about the lessons

Prior-knowledge

facilitate condition of learning

b. Presentation

Concept Development

- sufficiently develop the MELCs intended for the learning area and grade level
- logically developed and organized
- suitable to the learner's level of development, needs, experience, and context
- free from any type of error
- cognizant of intellectual property rights





Activities

· developmental and age appropriate

Assessments

- · aligned with the objectives and content
- · varied and involve self-check exercises
- · contain answer keys for objective type of questions

c. Application

Performance Task

 differentiated tasks based on the learner's multiple intelligences, learning styles, and readiness level

d. Generalization/Synthesis

process what has been learned by the learners

e. Post-assessment

evaluate the learner's level of mastery in achieving the objectives

2. Physical Attributes

Cover Page

- Cover art is appropriate, relevant, and interesting
- Includes grade level identifier, quarter number, learning area, module title, and module volume, when warranted

Front Matter Pages

• All necessary elements are complete (title page, copyright page, table of contents, and introduction of the module)

Text

- readable and suitable for the target users
- written in a conversational/narrative style

Visuals and Illustrations

- relevant to the text, age, culture, and life situation
- accurate representation of the concepts discussed
- sustain interest and do not distract attention of the learner
- free from objectionable biases or advertising
- proportionately drawn in size
- · appropriately placed in the page
- use appropriate color when needed in the understanding of concepts

3. Format

Design and Layout

- Contain enough space between words, between lines, and between texts and visuals
- Citations for graphics and visuals shall be on the same page
- Page endings do not end with a hyphenated word or an awkward page turn which affect readability
- Adequate illustrations in relation to text
- Harmonious blending of elements (e.g., illustrations and text)
- Properly laid out and sustain readability

Typeface and Font Size

- Appropriate for the target user
- Easy to read to enable the target users to easily identify themes and ideas

The following table shows the recommended typeface and font size:

Colored Pages

 SLMs are in one color except for Arts, Science, and Math with approximately 24 multiple colored inside pages

4. Medium of Instruction to be Used

On the basis of the information as to what grade level and learning areas shall be accepted for evaluation, the language to be used in the SLM is indicated in the following table:
