

- 1. - 2. Scholars are requested to accomplish the Scholarship Contract found in Enclosure 2 and submit the following documents to the National Educators Academy of the Philippines in compliance to Regional Memorandum No. 18, s. 2021, on or before January 17, 2022.
 - a. Letter of Intent addressed to the Regional Director, duly endorsed by the Assistant Regional Director;
 - b. Updated Personal Data Sheet;
 - c. Medical Certificate (Form 86) signed by a government physician;
 - d. Service Record duly signed by the immediate AO;
 - e. Photocopy of IPCRF for the last rating period;
 - f. Photocopy of Transcript of Records (Baccalaureate or Masters Degree, if any)
 - g. Certification of the HR Officer that the nominee has no pending scholarship nomination to other program.
 - h. Certification of the HR Officer that the nominee has never availed any scholarship program sponsored by DepEd or other attached agencies;
 - i. Certification of the HR Officer that the nominee is a permanent personnel;
 - j. NBI Clearance to support that the grantee has no pending criminal case; and
 - k. Certification from the Regional/Division Legal Officer that the Grantee has no pending administrative case.





- Scholars have to attend all classes as scheduled, complete course requirements on time and refrain from dropping from the course officially enrolled in. Otherwise, scholars are obliged to refund payment incurred for their course fees to the Regional Office.
- 4. Courses are also open to all interested participants, however, course fees shall be charged against their Division MOOE or any available local funds subject to the existing accounting and auditing rules and regulations.
