
Thank you for considering our request. We are hopeful for a favorable response and look forward to the active participation of our dedicated nurses in this momentous occasion.

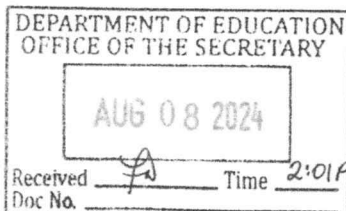
