DIVISION MONITORING ON EXPANDED GOVERNMENT ASSISTANCE TO STUDENTS AND TEACHERS IN PRIVATE EDUCATION (EGASTPE) IMPLEMENTATION

- 1. Schools Division Offices through the Monitoring Section, In-Charge of Private Schools, and the PSDSs of the Curriculum Implementation Division (CID) are hereby directed to monitor the implementation of the EGASTPE among private schools.
- 2. The monitoring shall focus on the implementation of the following:
 - Teachers' Salary Subsidy (TSS)

- 4. The reports shall serve as basis of this office in tracking the EGASTPE implementation in the Region.
