

- 1. DepEd-CAR, in coordination with the Regional and SDO CPUs and CREDes, will conduct the *First Regional Summit on the Rights of the Child cum Capacity Building for Learners and Duty-Bearers* with the theme "Karapatan ng Bata sa Edukasyon: Isulong at Isabuhay Natin!" on February 2-4, 2022 thru limited face-to-face and Zoom online platform;
- 2. The Regional Summit will be an avenue for learners and duty bearers to meet and present their programs and achievements related to children and child rights.
- 3. The Summit will also be a great opportunity to present the Child Rights in Education (RBE) Framework of DepED to the learners and duty bearers, to discuss the DepEd Order No. 003, s. 2021 entitled "Creation of the Child Protection Unit (CPU) and the Child Rights in Education Desk (CREDe) in the Department of Education," Cybersafety/Safe Spaces, and Mental Health Awareness. It will also be a platform to revisit DepEd Order No. 40, s. 2012 entitled "DepEd Child Protection Policy."

There shall be a total of 100 online participants per Schools Division Office comprising of 50 selected learners and 50 selected duty bearers and partners such as the School Child Protection Committee members, SDO CREDe and SDO CPU members, and identified partners.
