


To: Schools Division Superintendent Heads, Public Secondary Schools



- 1. Pursuant to Section 19 of the Implementing Rules and regulations of Republic Act No. 10533 or otherwise known as the "Enhanced Basic Education Act of 2013" and in response to the increasing gap between the competency levels of Filipino workforce and school graduates, and the lingering issue of jobs and skills mismatch in the labor market, there is a need to properly guide the students towards becoming productive and contributing individuals through informed career choices.
- 2. The Curriculum and Learning Management Division, DepEd-CAR, in partnership with DOLE-CAR will conduct a two-day Capacity Building for Guidance Counselors and Career Advocates at Ating Tahanan, Girl Scout of the Philippines, South Drive, Baguio City on July 17-18, 2014.
- 3. The capacity building aims to provide a venue for GC's and Career Advocates to be more actively involved in forming the minds of the youth and give them the needed support that will enable them to prepare for the world of work.

 Specifically, it aims to;
 - a. Capacitate and equip career guidance advocacy allies with up-to-date LMI trends, in the global and national contexts, for their use in effective and efficient delivery of career guidance to the students and iobseekers.
 - b. Update the GCs and CAs with new concepts and strategies for career guidance in the 21st century in order to assist learners in different life circumstances and cultural contexts to find them to more self-determined and fulfilling lives.
 - c. Recognize the potential of career growth in guidance and counseling, especially among GCs and CAs.
 - d. Identify the role of different stakeholders, including the private sector, in promoting career guidance advocacy.
 - e. Promote career guidance as a relevant tool in youth development, contributing to the prosperity and welfare of the nation.
