

TRAINING-WORKSHOP ON LEADING AND MANAGING THE K TO 12

CURRICULUM IMPLEMENTATION



- With reference to RA 10533, Rule III sec.12.3, DepEd/CHED/TESDA is responsible in school leadership training. Specifically, it cites: Superintendents, principals, subject area coordinators, and other instructional school leaders shall likewise undergo workshops and training to enhance their skills on their roles as academic, administrative, and community leaders.
- In view of this mandate, the DepEd Regional Office shall conduct a live in training-workshop on Leading and Managing the K to 12 Curriculum Implementation to all schools division from November 26-27, 2014 except Ifugao Division that will be on December 5-6, 2014. Venues shall be announced at a later date.
- 3. A culminating activity of all the clusters will be on January 15-16, 2015 tentatively at Teachers Camp, Baguio City.
- 4. The training-workshop aims to:
 - a. Increase participants' understanding and appreciation of the following areas of the K to 12 curriculum implementation and DepEd programs:
 - Assessment
 - Senior High School Curriculum
 - Senior High School Partnership
 - Alternative Delivery Mode/ Flexible Learning Options; LRMDS;SLAC Sessions
 - b. Enhance participants' skills and knowledge on:
 - Written Communication Skills;
 - School Based Management
 - New roles, functions and structure of the rationalized Regional Office
 - · Personality development
 - 5. Participants in the training are Superintendents, Assistant Superintendents, Education Program Supervisors, Public Schools District Supervisors and all Public Elementary and Secondary School Heads. Participants are clustered in the following:

Cluster 1: Baguio City, La Trinidad, Tuba, Sablan, Itogon 1 and 2

Cluster 2: Mankayan, Buguias, Atok and Tublay, Kibungan

Cluster 3: Kapangan, Bakun, Bokod and Kabayan

Cluster 4: Abra

Cluster 5: Apayao

Cluster 6: Ifugao – December 5-6, 2014

Cluster 7: Kalinga and Tabuk Cluster 8: Mountain Province

- 6. Travel expenses of participants shall be charged to the Maintenance and Other Operating Expenses/ local funds, while training kit, board and lodging of participants and training management team (resource speakers, facilitators & secretariat), travel expenses of training management team, miscellaneous and other incidental expenses relative to the training shall be charged to the Regional Office funds subject to the usual accounting and auditing rules and regulations.
- 7. The registration shall start at 4:00 P.M. on November 25 at the venue. The first meal to be served will be dinner of November 25 and the last meal will be dinner on November 27. Check out shall be before 12 noon of November 27. A schedule of activities is in the attached enclosure.
